






DuPage County Bicycle and Pedestrian Planning

- Subsequent updates in 1996 and 2008














IPP Aurora Branch – CN Railroad Underpass





Lisle / Naperville Ride

On Sunday, October 6, 2013, before sharing in the fun of the Green Trails Block Party, there will be a self guided or guided ride to introduce people from all over the area to some of the beautiful opportunities for walking, biking, inline skating or other self propelled means of transportation and recreation in the Lisle area. For those interested you can show up at Bicycles Etc. in College Square sometime between 10 a.m. and noon on October 6th. You may want to stop at Safari Café also in College Square as early as 9:30 a.m. for some carbo-loading and a cup of coffee, tea or other beverages.

At the bike shop you will receive a map of the trails. You can also have your bike checked if you haven't ridden it in a while. There will be people there who you can talk to about bike safety, and trail etiquette. If you would like a guided tour, we will have a tour guide leaving every half hour from 10 a.m. to noon. Once you decide on a route and start pedaling, you can ride or walk anywhere from 6 to 40 miles or less because you can turn around whenever you want. 






I-88 Central DuPage Bikeway
