4.0 Agency Reports:

CMAP Executive Director's Report

Executive Director Erin Aleman's asked Chair Secretary Osman to report on IDOT's recent decision to allow toll credits (transportation development credits)--in line with CMAP's policy allowing Cohort 4 communities to be exempted from providing local match in programming federal funds to be used as the local match for state projects—to waive local match for state projects that are in Cohort 4 communities.

Executive Director Erin Aleman continued reporting on the following: congratulations to Secretary having been recently confirmed as the 13th Secretary; CMAP new staff; American

Rescue Plan (ARP) funding update; recent CMAP correspondence to the Surface Transportation Board (STB) regarding the acquisition of the Kansas City Southern by Canadian National; STP/CMAQ/TAP call for projects update; and, CMAP's Regional Excellence Awards program, recipients to be announced at CMAP's inaugural State of the Region event in October.

CMAP Board Report

Leanne Redden reported that the CMAP Board: had met in April (covering committee reports and the state and federal legislative updates; in May (considering a draft revision to the bylaws and an ON TO 2050 update; and yesterday (approving the bylaws changes, conformity and a TIP amendment—also being presented today—as well as a regional freight rail presentation and the Executive Director's year-end report).

Council of Mayors Report

Mayor Jeffrey Schielke reported that the Council of Mayors Executive Committee had met April 20, and considered the following: the STP projects received during the latest call for projects; an updated from IDOT on local roads; an overview of CMAP's diversity, equity, and inclusion (DEI) work; a summary of COVID 19 economic impacts; an update on the agency's Local Government Network (LGN) outreach to municipalities; and an update on state and federal legislative activities. The committee meets next on July 20.

5.0 Nominating Committee for the Office of Vice Chair

Under authority as Chair of the MPO Policy Committee, Secretary Osman named Cook County DOTH Superintendent Sis Killen representing highway administration, Council of Mayors Chairman Mayor Jeff Schielke representing municipal governments, CTA CEO, Dorval Carter representing transit agencies, Kane County Chair Corinne Pierog representing counties, and CMAP Board Member Matt Brolley representing the regional planning agency to serve as a nominating committee to meet and make a recommendation to the Chair for the Office of Vice Chair.

6.0 Transportation Consent Agenda: Semi-Annual ON TO 2050/TIP Conformity Analysis and TIP Amendment

CMAP staff Russell Pietrowiak presented the semi-annual ON TO 2050/TIP conformity analysis and TIP amendment 21-06, that had been included in the packet, were subject to a 30-day public comment period from April 16-May 17, 2021, considered by CMAP's Transportation Committee, and requested approval. Pietrowiak also reported that McHenry County has now been classified as non-attainment, thus the attainment areas for both 2008 and 2015 are the same.

7.0 Self-Certification

Presented by CMAP staff, Teri Dixon, reported the following. By statute, every four years, the state and MPO are to certify that the planning process is being implemented based on applicable federal requirements. CMAP is certifying that we are adhering to these federal requirements for transportation planning and various Acts outlined in the certification. Considered and recommended for approval by the Transportation Committee, staff is seeking MPO Policy Committee approval.

A motion to approve the self-certification as presented, was made by Mayor Jeffery Schielke, seconded by Sis Killen, and a roll call vote followed:

On behalf of the FHWA, Arlene Kocher addressed the MPO Policy Committee regarding provisions of the ADA, discussed the importance of the ADA Transition Plans, a recent publication by MPC, the region's low compliance rate, and encouraged the MPO partners to work towards making progress on the region's compliance requirement, and to show improvement when the FHWA-FTA planning certification review takes place early next year.

8.0 Presentation: ON TO 2050 Plan Update

Deputy Executive Director Laura Wilkison reported that an update to our regional comprehensive plan, ON TO 2050, is required in October, 2022. Topics to be addressed include policy shifts, changing mobility, technical updates, the financial plan, targets, and performance measures, and evaluation of regionally significant projects. Wilkison also presented the timeline for the ON TO 2050 plan update and gave a brief description of the nine required (as well as two related, but not required projects) that will be completed prior to adoption of the ON TO 2050 plan update.

Following this intro CMAP staff, Lindsay Hollander, presented a comprehensive outline of the long-range financial plan for transportation, covering the forecast from ON TO 2050, the overall scope of the update project, and next steps.

9.0 Safety Resource Group Update

CMAP staff, Victoria Barrett Victoria Barrett provided an update on the Safety Action Agenda, which included a summary of the most-recent Safety Resource Group meeting in May, and a progress report on outreach, media and pilot projects relating to safety. Staff also summarized recent research and discussions on speed management. The Committee was asked for comments and input on the topic, as staff begins work on a speed management policy paper.

10.0 State Legislative Update

Government Affairs Director Gordon Smith, reported that the General Assembly had completed the majority of its work and over the Memorial Day weekend by passing a state budget that included IDOT (and other agency) appropriations for capital projects, as well as IDOT's state grant that has historically been used to fund state MPOs and CMAP. Staff will continue to analyze the budget with additional reporting in September. Smith also reported on various other measures that were passed by the General Assembly including a high-speed rail commission.

11.0 Federal Update

CMAP staff, Tim McMahon, gave the federal legislative update related primarily to surface transportation reauthorization including actions taken by the various committees in both chambers, the status of congressional member priority projects, the potential impacts of those projects on the region's TIP, and the American Jobs Plan.

12.0 Other Business

A final announcement acknowledging her support to the MPO Policy Committee, Sherry Kane, a long-term CMAP employee will retire at month's end.

There was no other business before the MPO Policy Committee.

13.0 Public Comment

There were no comments from the public.

14.0 Next Meeting

The MPO Policy Committee is scheduled to meet jointly with the CMAP Board on Wednesday, October 13, 2021.
