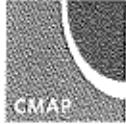

The McHenry County Council of Mayors respectfully requests that the Council of Mayors Executive Committee approve our request for advance funding in the amount of \$3,754,960 in federal Surface Transportation Program (STP) dollars. The request is for four projects in McHenry County scheduled for the 2014 lettings. The projects are:

- City of Crystal Lake – S. Main Street - \$1,500,000 federal – June 13, 2014 letting
- McHenry County – Miller Road - \$1,500,000 federal – June 13, 2014 letting
- Village of Algonquin – Bunker Hill Road - \$361,360 federal – February 28 letting.
- Village of Cary – Jandus Cutoff @ US 14 - \$393,600 federal – February 28, 2014 letting

We look forward to moving forward with these projects programmed for the February and June lettings. It is anticipated that with the completion of these four projects, the McHenry County Council of Mayors will not be requesting anymore advance funding in 2014.
