1.0 Call to Order and Introductions

Committee Chair Leanne Redden called the meeting to order at 9:30 a.m.

2.0 Agenda Changes and Announcements

Mr. Blankenhorn congratulated Mr. Buehler on his retirement from the Lake County Department of Transportation and thanked him for his years of service to the County and the region and for his work as a member of several CMAP committees.

3.0 Approval of Minutes – March 2, 2012

On a motion by Mr. Connelly, seconded by Mr. Seglin the minutes were approved as presented.

4.0 Coordinating Committee Reports

There was no Local Coordinating or Regional Coordinating meeting since the last Transportation Committee meeting.

5.0 FY 10-15 TIP Amendments and Administrative Modifications

On a motion by Ms. Trigg, seconded by Mr. Kopec, the TIP Amendments were approved as presented.

6.0 Proposed FY 2013 Unified Work Program – UWP

Ms. Dowdle provided an overview of the proposed FY 2013 UWP and amendments to the FY 2012 UWP. On a motion by Mr. Connelly, seconded by Mr. Seglin, the committee recommends Regional Coordinating Committee and MPO Policy Committee approval of the FY 2013 UWP and amendments to the FY 2012 UWP.

7.0 Congestion Mitigation and Air Quality (CMAQ) Improvement Program

Mr. Ferguson presented a summary of the CMAQ Project Selection Committee's recommended changes to the policies used in the development and management of the CMAQ program. Mr. Snyder asked if projects recently included in the 2012-2016 would automatically be updated to the proposed increased federal match percentages. Mr. Ferguson stated that sponsors will need to request changes to their funding for individual consideration. Mr. Seglin asked if the proposed obligation goal would be regionwide and if the goal would be a percentage of the annual allocation. Mr. Ferguson noted that the Project Selection Committee had not determined specific goals but had discussed setting goals to accomplish a spend-down of the unobligated balance within five years. The next call for projects, anticipated to begin in December 2012 for projects seeking funding in 2017 and 2018 was also discussed. On a motion by Mr. Snyder, seconded by Ms. Trigg, the committee recommends Regional Coordinating Committee and MPO Policy Committee approval of the updated CMAQ Programming and Management Polices.

8.0 Parking Strategies to Support Livable Communities (Lindsay Banks)

Ms. Banks presented an overview of the step-by-step guide CMAP created to help municipal governments address their parking concerns with the end goal of making communities more livable.

9.0 Legislative Update

Mr. Smith provided a brief overview of the status of CMAP's monitoring of state legislation and referred the committee to the 2012 State Legislative Summary contained in the agenda.

10.0 Reauthorization

Mr. Kopec reported that Conference Committee meetings are scheduled to begin in Congress on May 8, 2012 and that Illinois has both a House and a Senate representative on the committee. He reported that the Senate's MAP-21 proposal is likely to be the starting point of the committee's discussion.

11.0 Status of Local Technical Assistance Program and Major Capital Projects

Ms. Redden noted that updated status reports on the LTA program and GO TO 2040 Major Capital Projects were included in the agenda. Mr. Zucchero added that I-80 interchanges and I-294 and I-57 interchange work is underway. Mr. Seglin asked when the call for new LTA projects would begin. Staff stated that the call would begin on May 9, with applications due in August.

12.0 Other Business

Mr. Donovan reported that as a result of a request from the County Engineers, FHWA and IDOT would be examining the IDOT Agreement process during the next fiscal year.

13.0 Public Comment

Mr. Armstrong commented that Ms. Banks report was true with regards to free parking causing traffic congestion and sited Elmwood Park and Oak Park as examples. Ms. Armstrong stated that Bus Rapid Transit should be considered on Routes 145, 146 and 147 on Lakeshore Drive, where buses are overcrowded. Ms. Redden noted that those routes are currently being studied for BRT consideration in the future.

14.0 Next Meeting

The next meeting is scheduled for June 15, 2012.

15.0 Adjournment

On a motion by Mr. Connelly, seconded by Mr. Seglin the meeting adjourned at 10:35 a.m.

Re:	Supportive Land Use for Expressway-based BRT

GO TO 2040 identifies a set of priority transportation projects for the region, with a focus on moving the existing system toward a state of good repair. However, the set of priority projects also includes two highway extensions and three managed lane/multimodal corridor projects to add capacity to the system, each of which has the potential include transit. Bus Rapid Transit (BRT) is one option that has been identified to provide transit on these new and upgraded facilities and improve job-housing connections in the region. GO TO 2040 also supports transit oriented development (TOD) and seeks to broaden the definition of transit-supportive land use beyond areas around train stations. Therefore, the plan specifically recommends planning for supportive land use around expressway-based BRT stations.

To support this recommendation, CMAP staff has compiled research, case studies, and interviews on BRT-supportive land use and creating TOD in an expressway-dominated environment. This work has been compiled into two separate documents: the first is a technical report which contains a review of the literature, two case studies, and a summary of developer interviews; the second is Toolkit which offers land use policies and strategies for municipalities and transportation providers to consider when planning for expressway-based transit.

The Toolkit will be available in late June. It contains recommendations in four functional areas:

- 1) **Station Siting:** This section focuses on strategies for station placement to minimize the negative externalities of the expressway and increase the potential for TOD. Research has indicated that while supportive land use for BRT does not differ significantly from rail-based TOD, placement of stations in a location that is sheltered from the expressway is imperative to encourage supportive land use.
- 2) **Planning for and Implementing TOD in an Expressway Environment:** A number of traditional TOD strategies are reviewed, with a particular emphasis on how they might be utilized to create supportive land use in a traditionally auto-oriented environment.



- 3) **Pedestrian and Bicycle Connectivity:** Ensuring connectivity is a core tenet of TOD strategies and emerged as an especially critical strategy for the expressway environment.
- 4) **Marketing and Permanence:** This section provides strategies to address the negative perceptions that BRT and bus systems face related to the quality of service, the permanence of bus systems, and the ability of bus stations to generate development interest. Key takeways from interviews with local developers are also provided.

The Toolkit contains a first effort at providing guidance on station siting and land use decisions related to expressway-based BRT stations in the Region. CMAP will work with transit providers, transportation agencies, municipalities, and other stakeholders to implement the strategies outlined in this report. Initiatives may include publicizing the findings of this report, working with communities through the Local Technical Assistance Program, and assisting planning efforts for major capital projects. In particular, CMAP will continue to provide tools to communities seeking to implement transit-supportive land use policies and create livable communities. Changing longstanding land use and development policies can be a difficult task. However, these changes are imperative to support the region's transit system, decrease congestion, and improve quality of life.

Re:	Public Participation Plan Update

Federal law requires that Metropolitan Planning Organizations (MPO) develop a Public Participation Plan (PPP) that affords the public a reasonable opportunity to participate in and comment on transportation planning efforts. Last amended in August 2011, CMAP's PPP has not had a comprehensive update since it was originally written in 2007. The purpose of the PPP is to set forth CMAP's public participation goals and to provide a framework for how CMAP will approach public engagement.

To date, CMAP staff has been working with the Citizens' Advisory Committee (CAC) to review the current PPP and discuss how it can be more relevant to the work CMAP is doing. It is anticipated that with some revision the PPP will better reflect the agency's current approach to outreach on projects underway, as well as set the stage for future planning efforts. There will be a few minor "housekeeping" updates, such as:

- Removal of outdated references to CATS and NIPC
- GO TO 2040 principles will be folded in to the overview section
- Updated CMAP organization chart
- Updated MPO members chart

The majority of the update will focus on *Chapter 3: Public Involvement*, specifically section 3.3 *Public Participation Action Steps*. The focus on this section will be specifically to flesh out the stated goals and objectives in order to better illustrate the process that will ultimately help achieve the stated goals. In doing so, staff will refresh the public involvement process and methods to reflect current public participation efforts.

It is anticipated that this will be an ongoing project with the CAC through summer 2012. A final draft will be taken to the CMAP Board and MPO Policy Committee for approval at their joint meeting in October 2012.

GENERAL ASSEMBLY UPDATE

The Illinois General Assembly adjourned on May 31, successfully passing a FY13 budget, gambling expansion, enterprise zone legislation and all five bills CMAP supported, but failing to pass pension reforms and a \$2 license plate fee that would have helped fund the Department of Natural Resources.

At the beginning of the session, Governor Quinn called on legislators to reduce costs for Medicaid and public pensions. The governor requested elimination of a \$2.7 billion shortfall in Medicaid costs. Two bills totaling \$2.4 billion were passed, just shy of the Governor's goal. The first bill (SB 2840) includes \$1.6 billion in service cuts. The other bills include a new \$1-per-pack cigarette tax, estimated to bring the state \$700 million when paired with federal matching funds, and an assessment on hospitals expected to raise \$100 million.

Pension reform took many twists and turns, but ultimately lawmakers could not agree on a final package. The governor has stated that he will call legislators back into session to address pensions again. For more information on the details of the reforms, the Illinois Municipal League provides several summaries on the new laws.

CMAP staff closely watched budget activities this session, particularly the budgets and other funding issues for the Illinois Department of Transportation, Illinois Department of Natural Resources and the transit agencies. Funding for CMAP, through the metropolitan planning line item in IDOT's budget (SB 2474) was included. In addition to general operating and capital budgets for IDOT, the department also successfully acquired \$1.6 billion in bonding authority under the Illinois Jobs Now! Capital bill for FY13. Another finance authorization was provided to RTA for additional working cash notes, which are essentially short-term (i.e. less than 24-month) loans to cover operating expenses. Working Cash Notes can cover a cash flow deficit in anticipation of tax receipts or other future revenues. CMAP supported this legislation.

Last month we reported that IDNR was proposing legislation to help increase funding for the agency through park entrance fees through HB 5789. The bill stalled and an alternate bill began to advance, **SB 1566**, IDNR Sustainability Package. This bill failed to pass because it was called after the May 31 deadline. More information about SB 1566 is available online in a recent **Policy Update**.

In the final few days of session, the lawmakers passed gambling expansion legislation. It includes five new casinos (Chicago, Lake County, Rockford, south suburbs, and Danville), and allows for slot machines at the race tracks. The new monies are not expected to impact fiscal year 2013 revenues, and Governor Quinn has promised to veto the bill.

CMAP actively supported five bills: HBs 3859 (Tax Revenue Sharing Agreements), 3875 (RTA Working Cash Notes), 4496 (Plumbing Code Updates) and SBs 639 (School Construction) and 3216 (Public-Private Partnerships). Each passed and will be sent to the Governor for approval. The attached document shows the status of many of the bills CMAP tracked.

Re:	Local Technical Assistance Program Update

The CMAP Board and committees receive regular updates on the projects being undertaken through the Local Technical Assistance (LTA) program, including those receiving staff assistance and grants. To date, 56 local projects have been initiated. Of these, 38 projects are fully underway and 7 have been completed.

Two projects were completed in May; these include:

- The Park Forest sustainability plan, adopted by the Village of Park Forest on May 14.
- The redevelopment plan for the Old Joliet Prison and U.S. Steel site in Joliet, conducted in partnership with the Urban Land Institute (ULI).

In addition, the implementation of several recently completed projects has been advanced by grants made available by the Chicago Community Trust. At CMAP's Ideas Exchange event on May 24, the Trust announced five grants, all of which relate to and support LTA projects:

- The Active Transportation Alliance for "Communities for Complete Streets," in partnership with Blue Island, Des Plaines, Forest Park, Hoffman Estates, and Riverdale, whose long-range transportation plans will safely and seamlessly accommodate all users, including bicycles, public transportation vehicles and riders, and pedestrians of all ages and abilities.
- The Developing Communities Project "2012-13 Red Line Extension Campaign," which will prepare a transit-oriented master plan for economic development in support of a GO TO 2040 major capital project to extend the CTA Red Line south to 130th Street.
- The Seven Generations Ahead organization's project to implement high-priority measures -- including water conservation, energy efficiency, solid waste reduction, and green business development -- of "PlanItGreen," the official long-range environmental sustainability plan for Oak Park and River Forest.

- The Renaissance Collaborative "Bronzeville Retail Initiative" to coordinate economic development with innovative land use planning, strengthening an ongoing effort to restore the vibrancy of three commercial corridors: 43rd, 47th, and 51st streets.
- The Village of Park Forest "Growing Green" implementation project, which will institute education and outreach activities for the village's official long-range sustainability plan.

GO TO 2040 Major Capital Projects- June 2012 Update

Central Lake County Corridor: IL 53 North and IL 120 Limited Access

Project Status: Project is in the planning stage. The Illinois Route 53/120 Blue Ribbon Advisory Council has worked recently to identify consensus around options for the Illinois Route 53 corridor in central Lake County and develop a framework of principles to guide future study of the corridor configuration, timing and financing. The BRAC report was finalized on May 18. The Tollway Board will consider the report on June 28.

Overall Progress since Last Month:

- The Blue Ribbon Advisory Council reached consensus on a resolution and final report, by a vote of 27-2, and this report will be considered by the Tollway Board on June 28.
- The report calls for many notable design, environmental, financing, and land use considerations. Specifically, the Council agrees that:
 - "the new Route 53 should be a four-lane, limited access, tolled parkway with a 45 mile-per-hour maximum operating speed. The Council stresses that design elements defined in this resolution such as a depressed sections, earthen berms and stormwater treatment features are essential requirements and shall not be considered optional during the detailed design process."
 - "the project should be funded through the use of tolling, under a rate structure that includes congestion pricing and indexing of toll rates. The Council supports tolling existing Route 53 from Lake Cook Road to I-90 and a cooperative approach to develop a tolling plan that is equitable and uniform for all access points in Lake County; including adding tolls to existing un-tolled access points, adding tolls at the state border and adjusting the rates at the mainline Waukegan Plaza on the Tri-State Tollway. The Council also requires identification of local revenue sources, and supports the use of Tollway system generated revenues to enable this project which is vital to the region's mobility, economic development and quality of life."
- In addition, the report states that "a corridor plan that integrates land use, transportation, economic development and open space is vital to the success of the Route 53/120 project...Lake County and the corridor municipalities, with the cooperation of the Tollway, should apply for assistance through the CMAP's Local Technical Assistance program (LTA) via the upcoming round of applications, due in August 2012. The LTA will not be a sufficient source of resources but it would provide a beginning point and complement other sources of funding. The Tollway, CMAP, Lake County and other key partners will be responsible for obtaining funding for the plan."

CMAP's Contribution since Last Month:

• Given the recommendation for a corridor plan, CMAP has referred Lake County entities to the Local Technical Assistance call for projects, as referenced in the BRAC final report.

I-90

Project Status: Project is in design. The Illinois Tollway's I-90 Corridor Planning Council issued findings and recommendations on April 5, 2012. They can be found here: <u>http://www.illinoistollway.com/documents/10157/48742/I 90+CPC+report+v11.pdf</u>

Overall Progress since Last Month:

- Tollway awarded contract \$26.9 million to BV3 for corridor management and design services for the reconstruction and widening of the Jane Addams from Higgins Road to the Elgin Toll Plaza.
- Tollway awarded five design services contracts for the reconstruction and widening of the Jane Addams: \$23.4 million to Parsons Brinckerhoff Inc.; \$16.4 million to Crawford, Murphy & Tilly Inc.; \$24.2 million to HDR Engineering Inc.; \$2.7 million to ABNA of Illinois Inc.; and \$5.4 million to Elmhurst Joint Venture.
- Tollway Board met on May 24th. Corridor Planning Council Chairs (Ernst/Kopec) presented the recommendations of the Council to the Board. Although no action was taken by the Board, the conversation was generally positive and centered around the use of transit on the managed lane. Tollway staff explained that the construction plans will include all infrastructure necessary to implement variable pricing on the new lane, reserved right of way to further expand to a transit only lane (including rail), and the separate accommodation of transit vehicles at certain locations stations and O'Hare Airport.
- The Corridor Planning Council, while their work is officially done, will likely be reactivated in subgroups to address specific implementation issues.

CMAP's Contribution since Last Month:

- This project was discussed as part of the CMAP Advanced Technology Task Force (ATTF) which met on May 31st. The Tollway desires to create a testbed for an expressway Smart Corridor, which would include infrastructure needed to support vehicle to vehicle (V2V) and vehicle to infrastructure (V2I) communication as well as the investment necessary to support congestion pricing and incident management. CMAP will add this project architecture to the region's official ITS Architecture and send it up the committee structure for approval.
- CMAP provided C12Q1 datasets to Delcan to review for the I-90 study. CMAP agreed to perform modeling to support this analysis. Depending on the project needs and schedule, either the 4-step or pricing model will be used.
- CMAP provided traffic projections to BCP Tollway Partners for Randall Road and US 20 interchanges with I-90 and adjacent intersections, to ensure that the plans for I-90 properly address future demand at these locations. CMAP is currently developing traffic projections at I-90 and Barrington Road for the village of Hoffman Estates. Completing this interchange to allow all movements is under consideration.
- Participation on the Corridor Planning Council including a presentation to the Tollway Board.

Elgin O'Hare

Project Status: Tier 2 engineering and environmental is underway.

Overall Progress since Last Month:

- Illinois Dept. of Transportation (IDOT) and Illinois Tollway Authority (ITA) officials and engineers hosted a public hearing in Elk Grove Village discussing the planned \$3.4 billion Elgin O'Hare West Bypass (EOWB) Expressway project. Construction would move west-to-east on the project beginning in 2013 continuing through 2025 with a few notable eastern sections beginning earlier. Other longer range unfunded improvements were also detailed at the event.
- Tollway awarded contract \$66.8 million to CH2M Hill Inc. for corridor management and design services for the Elgin O'Hare West Bypass.
- Final meeting of the Corridor Planning Group will be held Thursday, June 14th. Agenda <u>here</u>.

CMAP's Contribution since Last Month:

- CMAP staff reviewed the Draft EIS and provided recommendations for improving the discussions of socio-economic forecasts, housing, environmental management practices and commitment to state-of-the-art de-icing methods.
- Will attend final Corridor Planning Group meeting.

CTA Red and Purple Line Modernization

Project Status: CTA and Federal Transit Administration (FTA) have initiated the environmental review process for this project and will be preparing an EIS.

Overall Progress since Last Month: Announcements were made about upcoming station closures.

CMAP's Contribution since Last Month:

• CTA has been preliminarily awarded \$517,500 in EIS work via the FY 13 UWP process (approval in June).

CTA Red Line South

Project Status: CTA and Federal Transit Administration (FTA) have initiated the environmental review process for this project and will be preparing an EIS.

Overall Progress since Last Month:

• CTA has been preliminarily awarded \$517,500 in EIS work via the FY 13 UWP process (approval in June).

CMAP's Contribution since Last Month:

• Through the Local Technical Assistance Program, CMAP is providing assistance with work on a quantitative analysis and has completed a draft interim project report for the project area. To date, four community focus groups have taken place. CMAP is working with the Developing Communities project and CURL staff to schedule 11 additional focus groups and 20 individual interviews between June and August. Community Education Session planning in conjunction with CTA is currently underway.

I-290 Multimodal Corridor

Project Status: The I-290 Preliminary Engineering and Environmental (Phase I) Study started from a clean slate in Fall of 2009. The process is consistent with the National Environmental Policy Act (NEPA) and will result in an Environmental Impact Statement (EIS) for the reconstruction of I-290 from west of Mannheim Road to east of Cicero Avenue. The preferred alternative selection and EIS should be completed in fall of 2013.

Overall Progress since Last Month: IDOT met with individual communities to discuss and receive input on interchange design concepts. The study developed round 2 combination mode alternative screening information and documents. Each of the combination mode alternatives includes express bus. The combination mode alternatives were each tested with and without high-capacity transit (HCT), which is a generic representation of either extension of the Blue Line or BRT serving the Blue Line terminal station. The Community Advisory Group will meet June 11 to discuss the alternatives evaluation and have a workshop on interchanges and access.

CMAP's Contribution since Last Month: None

West Loop Transportation Center

Project Status: Phase I of the Union Station Master Plan concluded in May. Projects to create a surface bus transfer center and East-West BRT are funded and underway. The projects begin to address improving connections between Union Station and other transportation services.

Overall Progress since Last Month:

A Union Station Master Plan effort was concluded and a report was released on May 23rd, 2012. This is available on the project website. The report includes short, medium, and long term project recommendations.

CMAP's Contribution since Last Month:

CMAP provided comments on the draft report which were focused on promoting the understanding of the West Loop Transportation Center project as a large concept which covers a number of potential capital investments. CMAP reviewed and provided comments on the RFP CDOT is developing for Phase II of the Union Station Master Plan Study. Phase II will include modeling of station passenger circulation and rail operations. CMAP desires that the study include specific consideration of Intelligent Transportation System (ITS) systems, especially appropriate equipment and locations to meet passenger needs. CMAP also recommended that the modeling specifically address the needs of senior citizens and people with disabilities.

I-294/57 Interchange

Project Status: Construction has begun.

Overall Progress since Last Month: The Illinois Tollway awarded a \$574,000 contract to CivicCon Services Inc. for realignment of Dixie Creek. This is required because the creek currently runs through the pathway of one of the future interchange ramps. This will be completed by the end of the summer. The Illinois Tollway will also reconstruct the bridges that carry I-294 over 147th Street this year.

IDOT has a contract with Lorig Construction for \$27.9 million to reconstruct the bridge on I-57 over I-294 which should be complete in September 2012. IDOT will also reconstruct the bridge that carries Kedzie Avenue over I-57 under a future contract.

- Construction Update (06-05-2012) Between I-57 and Kedzie Avenue, traffic in both directions is reduced from four lanes to three lanes and traffic in both directions is shifted onto the northbound bridge allowing workers to reconstruct the southbound bridge.
- At 147th Street, traffic is reduced to one lane in both directions for bridge demolition and reconstruction.
- Consultant selection for the LTA project is currently taking place.

CMAP's Contribution since Last Month: CMAP is providing staff assistance as well as consulting assistance via the LTA program for an SSMMA interchange land use planning project. This project will involve planning for land use and economic development for five communities near the new I-294/I-57 interchange (Dixmoor, Harvey, Markham, Midlothian, and Posen). Project scoping is ongoing and kickoff is expected in June, with consultant involvement expected to begin in July.

Illiana Expressway

Project Status: Tier 1 EIS process

Overall Progress since Last Month:

- <u>SB 3318</u>, which was passed by the Senate and the House and is expected to be signed by the Governor, would allow IDOT to acquire property for the Illiana Expressway using eminent domain authority and removes restrictions regarding quick-take powers.
- Work continued on the Tier 1 Draft EIS. Three corridors examined in further detail. Tier 1 scheduled to be release for comment during July 2012, with a public hearing on July 31 in Illinois (August 1 in Indiana). Tier 1 Final EIS to be submitted during the fall of 2012 with a Tier 1 Record of Decision in early 2013.
- Of the three alternatives being carried forward, the more southern route is still looked upon as the most viable alternative by the study team.

CMAP's Contribution since Last Month:

• CMAP provided comments about the Draft Purpose and Need Statement. Two primary concerns were how the corridor would be funded and also told them they had to evaluate

the project using the GO TO 2040 socioeconomic file in addition to the special purpose one they developed.

- CMAP provided comments regarding the preferred corridor alignment on March 14, 2012. CMAP's main concerns are that the preferred alignment is too far south to provide significant mobility benefits to the region. In addition, the alignment will not carry enough traffic to enough toll revenue to fund the project.
- CMAP met with IDOT and the consultant regarding comments on the alternatives analysis results. Rather than a single alignment being carried forward, three alternatives were further analyzed.
- Attended the Corridor Planning Group meeting on June 6th. Presentations by the study team on the analysis of the three remaining corridors and on the travel forecasting methods employed.
