## **MEMORANDUM**

**Re:** FY 2013 UWP Competitive Proposals

On January 5, 2012 a Call for Projects was made for the FY 2013 UWP proposals. Seven proposals were received for the core projects and fifteen for the competitive projects. The UWP Committee acted upon the core proposals at its meeting on February 29, 2012.

At the March 7 meeting the agency submitting the proposals discussed the projects and then the Committee members ranked the proposals. The ranking of the Committee is reflected in Table 1.

In the fall the Committee was informed that the total federal funds available for FY 2013 would be \$18,000,000. As announced at the last meeting, IDOT has revised its FY 2013 mark based on the actual funds received as of December 31. The new mark in federal funds for FY 2012 is \$14,848,614. In addition, there is \$2,499,000 unallocated from the FY 2011 PL funds. At this time, the FY 2013 UWP federal funds will be \$17,347,614.

In February, the Committee approved the core program at \$14,140,334 federal funds, or \$17,877,555 total program. With the reduction in federal funds, the remaining federal funds to be allocated are \$3,207,280 federal funds, or \$4,009,100 total program.

Taking into account the overall scores for the competitive projects and the reduced overall funding amount, CMAP recommends the following for the FY 2013 UWP program. Please note that all the funding amounts are in federal dollars.

- 1. Reallocation of \$100,000 in federal funds from the core program to the competitive program by reducing CMAP by \$20,000 and the City of Chicago by \$80,000.
- 2. Competitive projects receiving scores of 15 or above be funded for the FY 2013 UWP program.
- 3. The Competitive projects with scores of 16 and above be reduced by 10% (a total reduction of \$197,600 in federal funds), with the exception of CMAP's Local Planning Assistance, be reduced by 20% (a reduction of \$352,000 in federal funds). Pace's Real Time Information Coordination should not be reduced since the request is for a lower funding amount, \$108,000.
- 4. If additional funds become available as we await further federal action on the Transportation Reauthorization, additional projects would be funded in line with the committee's ranking of the competitive proposals.
- 5. Table 3 reflects the FY 2013 UWP recommended program.
