Purpose: The purpose of this project is to comply with federal planning requirements (23 CFR Part 450) and certification emphasis areas that relate to safety and non-motorized planning. This funding supplement will cover the remaining staff time not included in the Core funding and will fund a consultant for the Year 2, Pedestrian Safety Initiative.

If the project relates to an emphasis area, please explain: Safety: This project will help make a safer environment for cyclists and pedestrians. Context-sensitive solutions: project provides requested information to implementing agencies regarding existing and planned non-motorized facilities, and provides other information necessary for accommodation of non-motorized travel using our transportation system. Planning for Transit Systems Management/Operations to Increase Ridership: planning for improved non-motorized accommodations, particularly for pedestrians, is a transportation management strategy that facilitates higher transit ridership, since most transit trips require non-motorized travel for at least part of the trip. Limited non-motorized access has been identified as an important barrier to increasing travel by bus and rail.

Major tasks: With sufficient resources, the Plan Development Division will hold quarterly Bicycle and Pedestrian Task Force meetings. The overall goal is to safely facilitate walking and bicycling in support of reducing VMT, supporting community and economic development, and supporting our transit system. The Bicycle and Pedestrian Task Force provides guidance and agency support for the following initiatives: (1) Pedestrian Safety Initiative, as approved in the FY 2006 UWP, the RFP for which is now being issued by IDOT, which will (a) develop and institute a pedestrian safety review procedure for the preliminary engineering process; (b) implement a concentrated pedestrian safety enforcement, education, and engineering effort in competitively selected communities; and (c) promote and make available pre-packaged pedestrian safety programs regionwide; (2) providing non-motorized planning assistance (a) in support of highway projects' accommodation of bicycling and walking, (b) maintaining an inventory of existing and planned facilities as required by USDOT metropolitan planning regulations, (c) supporting local and subregional plan development upon request, and (3) providing technical assistance to local and regional agencies (a) through bike and ped planning workshops such as the three 2005 workshops concerning intersection design and providing accessible routes for people with disabilities, (b)developing multi-media training resources, (c) supporting local and subregional project development, upon request; and (4) complete and begin implementation of Soles and Spokes Pedestrian and Bicycle Plan for Chicago Area Transportation, a project delayed because of competing staff priorities (e.g., Regional Transportation Plan). Remaining tasks include the completion of the best practices guide, completion of policy proposals, and the compilation of documents for review and adoption.

The supplemental request includes consultant funds for the Year 2, Pedestrian Safety Initiative (completing this contract), and supplemental staff for on-going activities.


