On September 10, 2013 the Council of Mayors Executive Committee approved an advance funding request for \$1,500,000 in STP dollars for the Johnsburg Road project in McHenry County. In November 2013, the Local Agency Agreement was submitted to IDOT with the federal STP amount listed as \$943,487.

Therefore, the McHenry County Council of Mayors requests that the federal STP amount allocated for the project decrease from \$1,500,000 to \$943,487.
