- 3.1 **GO TO 2040 Update** (CMAP staff)
As required under MAP-21, staff has worked on updating GO TO 2040 since the summer of 2013. The draft plan was released for public comment on June 11. Outreach meetings were held throughout the region through the end of the public comment period on August 1. Staff will present a summary of the public comments that were received as well as proposed changes to the plan update. Adoption of the final plan update is anticipated at the October joint meeting of the Board and MPO Policy Committee.

- 3.2 **Cal-Sag Trail**
Dave Landeweer, engineer with URS, will present on the Cal-Sag Trail, giving an overview of the planning, programming, design, and construction (to date) of the trail, outlining anticipated future work, and describing segments of the 26-mile trail that remain un-engineered and/or unfunded. The Trail has succeeded in obtaining funding through the TAP, CMAQ, and ITEP programs, and in securing local match funds from municipalities, the Forest Preserve District of Cook County, and other partners.

- 3.3 **The 606 - Bloomingdale Trail**
Luis Benitez, Assistant Chief Engineer/Chief Bridge Engineer with CDOT, will present on The 606 (Bloomingdale) Trail, which has been under construction since September 2013 and is expected to continue through 2015. Mr. Benitez will give an overview of the trail's history and development – the

vision, planning, design, and engineering – and what lies ahead in terms of construction, anticipated completion date, and subsequent use of the new park space.
