**CNT is working in two neighborhoods in the City of Chicago - Chatham and Albany Park - to help residents get Rain Ready. This application is for resources and skills to take this work further by developing Rain Ready plans for the neighborhoods, with a focus on streets, alleys, parkways, trails, parking lots and transit.**

**Rain Ready is a grassroots initiative aimed at helping individuals, businesses, and communities find solutions to the problem of too much or too little water, with a focus on swift, affordable and nature-based solutions. The initiative has been generously funded by the City of Chicago, the Surdna Foundation, Prince Charitable Trusts, Grand Victoria Foundation, the Joyce Foundation, and State Farm.**

**Albany Park has been the site of two devastating floods over the past six years. Residents are affected both by overbank/riverine flooding, and by basement back-up and seepage problems. A lot of the problems occur as a result of overland flooding across the City's streets.**

**The North River Commission recently hosted an event to bring together the key players who might help us tackle the serious problems that residents and businesses are facing. Albany Park is anticipating significant investment in and expansion of its grey infrastructure. This investment is expected to partially alleviate the problems, but further investment in decentralized infrastructure**

solutions is necessary. The North River Commission is particularly interested in swift, nonstructural and green solutions that form part of the Rain Ready initiative.

The Rain Ready plan will be developed with the North River Commission, the aldermen serving the Albany Park area (Deb Mell, 33rd and Marge Laurino, 39th), and with the support of the City of Chicago.

Although there are no floodplains in the community, research by CNT (The Prevalence and Cost of Urban Flooding) found that Chatham zip codes—60619 and 60620—have some of the highest flood damage payouts in Cook County. Between 2007 and 2011, urban flooding has resulted in 16,400 claims and \$44 million in payouts. CNT has already carried out work in the neighborhood: we hosted an event, produced an event report, and are now working with residents in West Chesterfield to help retrofit their properties with plumbing and landscape solutions. This work is being done with the Historic Chicago Bungalow Association, Greater Chatham Alliance, and Gathering Point Community Council. A Rain Ready plan, developed with these same partners, would provide a more strategic set of solutions for the neighborhood.

The process for developing a Rain Ready plan is outlined [here](#). It includes conducting a [community needs assessment](#) to help residents understand the nature and scale of the problems, and to identify appropriate solutions. Much of the focus is on analysis and assessments of individual properties affected by flooding (for example see this [video](#)) to understand the mix of solutions that might be needed within the property and in the public rights-of-way.

To help develop a robust Rain Ready plan, the communities need help determining the links and opportunities between rain readiness, land use, transportation, and housing. In particular, we would benefit from CMAP LTA expertise in: community engagement, green infrastructure opportunities within public rights-of-way (landscape architecture and engineering), land-use planning and financing.

The work will be filmed and documented on the Rain Ready website to help ensure that lessons learnt are replicated elsewhere.
