- 3.1 **McHenry County Long Range Transportation Plan – Bicycle and Pedestrian Chapter**  
Scott Hennings, of the McHenry County Division of Transportation, will present on the development of the County's Long Range Transportation Plan (2014) and, more specifically, on the chapter covering bicycle and pedestrian transportation.

- 3.2 **Local Technical Assistance (LTA) Program: Des Plaines River Corridor Plan**  
A corridor plan focused on improving access to and enhancing the transportation and recreational value of the Des Plaines River Trail and corridor in northern Cook County was developed through the LTA program, in partnership with the Northwest Municipal Conference, Houseal Lavigne Associates, Active Transportation Alliance, and communities along the corridor within the study area. An overview of the plan will be presented.

A recent evaluation of the LTA program highlighted the importance of local commitment. #### 4.2 Complete Streets Toolkit

CMAP, as part of its Local Ordinance and Toolkits program, has developed a Complete Streets Toolkit. This toolkit is the result of collaboration between the CMAP, Active Transportation Alliance, and the National Complete Streets Coalition. The toolkit is a guide for incorporating a Complete Streets approach into local planning, design, and construction processes and documents.

#### 4.3 2010 Land Use Inventory

CMAP periodically conducts a survey of the region's land use, publishing the results in GIS format as the [Land Use Inventory](#). The inventory is an essential input to CMAP's land use and transportation research. Other users of the data include planning departments, transportation agencies, federal and state agencies, university researchers, non-governmental organizations, and consulting firms. CMAP staff (David Clark) will provide an overview of this new, publicly-available planning resource.
