5.0 Connected Centers (Peter Rafferty and Adam Francour)

The Great Lakes Regional Transportation Operations Coalition (GLRTOC) will present on the Connected Centers project. The presentation will highlight the connected centers information exchange tools and connected centers information resources. The exchange tools describe the role of the Travel Midwest website, a structure for Traffic Operations Center (TOC) operators to exchange information among jurisdictions, and TOC collaboration. The connected centers information resources include TOC profiles for 22 TOCs in the GLRTOC coverage area and standard operating procedures for TOC operators to use.

6.0 Transit Signal Priority (TSP) (Mark Pitstick)

RTA staff will present on the progress of the Regional TSP implementation program. The Regional TSP program was awarded CMAQ funding in 2012 to implement TSP along priority transit corridors. The presentation will give an overview of TSP, proposed TSP corridors in the region, equipment used by TSP, and challenges and opportunities realized from the project.
