The subject project is being deleted from the TIP. It consists of a new commuter parking lot and a new road serving as an access drive. The

parking lot duplicates a CMAQ project, Naperville Park 'n Ride Lot - 95th and EJ&E (TIP ID 08-05-0004). The access drive is not coded in the network for modeling purposes. Consultation team concurrence is sought to delete this project without a conformity analysis.

In processing TIP revisions for the March 28 Transportation Committee meeting, the need for refinement of the TI P Procedures with respect to "grouped projects" was noted.
