THE FOX RIVER CORRIDOR PLAN FOR MCHENRY AND LAKE COUNTIES


The corridor plan will be the vision of what the communities want the area to become over the next 10 to 15 years and the steps needed to meet that goal.

THE BENEFITS OF HAVING A CORRIDOR PLAN FOR THE FOX RIVER


- Builds on Village, County, Conservation

Fox River Corridor Plan for the Villages of Algonquin and Carpentersville (2015)


THE FOX RIVER CORRIDOR:STUDY AREA


Broad themes:

- Attract more family-friendly businesses and activities





WATER QUALITY

- Water pollution affects aquatic life and limits recreation
- Groundwater contamination and depletion are threats to water supply and aquatic habitat
- Many groups are working to improve water quality



FLOODING

Causes property damage, reduces quality of life and business revenue, and water quality issues

FLOODING

- A 100-year flood: has more than a 1 in 4 chance of occurring within the term of a 30-year mortgage
- We are experiencing more precipitation: between 1979 and 2009, the Chicago region experienced <u>40 percent</u> <u>more precipitation</u> than the prior 30-year period.
- Storm events are also getting bigger: up to 40 percent of total annual precipitation in recent years came from the <u>top 10 rainiest days</u>.

OPEN SPACE AND HABITAT

Open space in the Corridor provides multiple benefits (biodiversity, flood control, water quality enhancements, recreation)

Access to open space can be limited due to environmental constraints



PARKS & RECREATION

Opportunity to expand recreational amenities and improve safety for all users



TRANSPORTATION & CONNECTIVITY

- Few public access points exist
- Sedimentation limits access for boaters
- Recreational paddling is increasing in popularity
- Existing and planned trails support a robust bicycle and pedestrian network
 - Planned trails are on streets and other public land. There is no planned riverfront trail.





ECONOMIC DEVELOPMENT

- Opportunity to expand businesses offerings and events
- Some development opportunities exist and should protect natural resources
- Capitalize on downtown reinvestment in Fox River Grove and Cary
