5.0 Regional Traffic Management Center (Mike Tuman & Jon Nelson)

Traffic management centers (TMCs) are the cornerstone of arterial traffic management, and CMAPs ON TO 2050 Highway Operations strategy paper identified that expanding their geographic coverage and hours of operation should be a regional priority. One way to achieve TMC coverage expansion is to take a regional approach to traffic management activities. Mr. Tuman (DuPage DOT) and Mr. Nelson (Lake DOT) will provide an update on the concept to develop a regional TMC.

6.0 Regional Expressway Vision (Thomas Murtha)

Staff will introduce a project to develop a multi-jurisdictional vision to guide future capital investments, coordinate transportation operations, and recommend policy and management strategies for the existing expressway system in northeastern Illinois. Transit, freight, community impacts, and revenue will all be key aspects of the vision. Staff will review draft vision goal statements and seek committee feedback.

7.0 CMAQ Program Development (Doug Ferguson)

The RTOC is tasked with reviewing and providing input on the proposed traffic flow improvement projects.
