1.0 Call to Order

Carolyn Schofield, Chair, called the meeting to order at 8:01 a.m., and members introduced themselves.

2.0 Agenda Changes and Announcements

There were no agenda changes or announcements.

3.0 Approval of Minutes

The Committee approved the meeting minutes from the June 13, 2018 meeting.

4.0 ON TO 2050: Review of the ON TO 2050 Engagement Process

Jane Grover provided an overview of public engagement carried out by CMAP during development of ON TO 2050, including three focused outreach phases. Outreach included 10 forums and 277 workshops reaching 4,750 residents, and more than 100,000

kiosk interactions. The first phase in 2016 focused on challenges and opportunities in the region and resulted in the Emerging Priorities Report. The second phase in summer 2017 used scenario planning to explore "alternative futures" the region might face and resulted in the ON TO 2050 Preview Report. CMAP also conducted significant youth and corporate engagement. The third phase during summer 2018 collected public input on the draft ON TO 2050 plan, which included 38 presentations to CMAP committees, 11 open houses, and one public hearing. CMAP received nearly 1,000 public comments during this period. For each phase, Grover discussed the priority issues raised by residents and stakeholders.

Mark VanKerkhoff thanked CMAP for its consistent outreach efforts to the collar counties, including via kiosks, forums, and open houses.

5.0 ON TO 2050: Discussion of Revisions from the Public Comment

Liz Schuh discussed public comments received on the draft plan and changes that were made in response. She provided an overview of the types of comment received as well as which portion of the plan they were directed to. The largest number of comments were on regionally significant projects, with the rest of the Mobility chapter also a source of many comments. Changes were made throughout the plan in response to comments, with overarching changes related to planning for residents with disabilities, emphasizing the historic roots of today's racial inequities, better connecting recommendations and plan indicators, and highlighting more local examples and best practices. Other notable changes related to recommendations addressing tax policy, economic development, a vehicle miles traveled fee, and impacts of freight movement on communities.

In response to a question from Richard Reinbold, Schuh stated that an approach for responding to commenters individually was still being formulated.

Michael Davidson congratulated CMAP on its work, and he inquired how implementation of ON TO 2050 would proceed and whether the process would be different from that used for GO TO 2040. Schuh responded that a later presentation would address implementation items involving external partners. Implementation is also reflected via CMAP's work planning document and transportation programming initiatives. GO TO 2040 implementation involved creation of the Local Technical Assistance program, and ON TO 2050 implementation will refine that program to reflect the new plan, including initiatives related to capacity building. On the policy front, implementation will address issues such as emerging technology and regional collaboration for economic development.

In response to a question from Jason Keller about incentivizing partnerships and collaboration, Schuh noted that the plan contains a recommendation that the state create a program to fund feasibility studies for service sharing and consolidation. CMAP also encourages and rewards collaboration where possible. Rocco Zucchero added that CMAP incentivizes collaboration in its transportation programming decisions, such as CMAQ project selection.

6.0 ON TO 2050: Implementation Priorities

Andrew Williams-Clark provided an overview of recently initiated activities to implement draft ON TO 2050 recommendations. The discussed projects require coordination with external stakeholders, and most are in early stages.

In response to a question from Michael Davidson about green jobs, Simone Weil stated that CMAP has coordinated with the Voorhees Center at UIC in this area. Davidson also inquired about the goal of working with IDOT revise design manuals; Liz Schuh stated that CMAP has proposed through a technical advisory group that IDOT research this issue.

In response to a question from Mark VanKerkhoff about Opportunity Zones, Williams-Clark noted that CMAP is doing analysis but has not made recommendations since the issue is emergent. Jason Keller stated that the Federal Reserve is partnering with CMAP to analyze Opportunity Zones in the seven-county region. He noted that many different types of entities can form a fund to take advantage of this tax incentive.

In response to a question from Carolyn Schofield about including a timeline in the memo for each project, Williams-Clark noted that many projects do not have specific timeframes because they are early in the planning process; however, CMAP's work plan does reflect a number of the projects.

7.0 Local Technical Assistance (LTA) 2018 Call for Projects

Anthony Manno announced that the 2018 LTA Call for Projects opened September 6th and that CMAP is once again partnering with the RTA's Community Planning Program. Applications are due at noon on October 26th. CMAP conducted an information session on September 11th and will be conducting workshops in each county prior to the application deadline. The intent is have proposed selections for MPO Policy Committee and CMAP Board approval in February or March. Project start dates will likely be staggered, with the first projects beginning around July 2019.

In response to a question from Jason Keller about projects that were unsuccessful in previous years that have reapplied, Manno noted that CMAP conducts a debrief with unsuccessful applicants and encourages open communication to strengthen applications. Carolyn Schofield noted that McHenry County had success resubmitting a project with adjustments made based on feedback from CMAP staff.

In response to a comment from Michael Davidson, Manno noted that the initial application is shorter than it was in previous years and is intended to collect general information about proposed project scope and partners.

In response to a question from Carolyn Schofield, Manno stated that workshop dates and locations would be forthcoming.

8.0 Other Business

There was no other business presented.

9.0 Public Comment

There was no public comment.

10.0 Next Meeting

The Planning Committee is scheduled to meet next on October 3, 2018 at 9:30 a.m.

1.0 Call to Order

Jason Navota, serving as Chair, called the meeting to order at 8:06 a.m.

2.0 Agenda Changes and Announcements

None.

3.0 Approval of Minutes – March 14, 2018

Approval of the minutes was postponed until quorum, after which they were approved.

4.0 ON TO 2050: Launch Event

Staff presented date of the plan launch event. Wednesday, October 10, 2018 from 10:00 am to noon, at Millennium Park. Committee members were encouraged to register and help promote the event. Approximately 1000 attendees are expected.

5.0 2019 Unified Work Program (UWP)

Staff presented the 2019 Unified Work Program including a few details. The total budget of \$22.4 million includes \$17.9 million in federal funds matched by \$4.5 million in state matching funds. The budget includes approximately \$21 million in core funding for

CMAP and partner agencies, and approximately \$1.5 million in competitive funds. Partner agencies' core budgets increased 5% on average over the previous year. Approval of the program was postponed until quorum, after which it was approved.

6.0 North Lawndale Neighborhood Plan

Staff and Cook County Commissioner Dennis Deer presented the nearly completed North Lawndale neighborhood plan. A committee member reminded the committee that North Lawndale previously participated in the HOMES program. A committee member asked about the plan's impact on the greater Lawndale area.

7.0 Pilot Pavement Management Program

Staff presented a recommended list of communities to participate in the pilot program. Approval of the program was postponed until quorum, after which it was approved.

8.0 Local Technical Assistance (LTA) 2018 Call for Projects

Staff presented the LTA Call for Projects application dates of September 6 to October 26. A committee member inquired about the implementation program. Staff explained the online engagement platform pilot project that is currently underway. A committee member inquired when applicants would be notified whether their application was successful. Staff replied they would be notified after the new year.

9.0 LTA Program Update

The Board receives monthly updates on the status of each active project within the LTA program. The latest update was provided.

10.0 State Legislative Update

Staff updated the committee on passage of the state budget, and updates on bills being tracked was provided in members' meeting materials.

11.0 Other Business

One board member arrived late, providing a quorum, after which the minutes, Unified Work Program, and Pilot Pavement Management Program were approved.

On September 28, 2018, the Transportation Committee recommended adoption of the ON TO 2050 Plan, the ON TO 2050/FFY 2019-2024 TIP Conformity Analysis, and the FFY 2019-2024 Transportation Improvement Program (TIP) to the CMAP Board and MPO Policy Committee. The full plan and appendices are as follows.

Public comment was open from June 15, through August 14, 2018. Staff provided a revised ON TO 2050 Plan as well as a response log for discussion at Transportation Committee, the Planning Committee, the CMAP Board, and other committees earlier in September. Discussions at these committees offered questions about the process and support for various recommendations and changes, but did not request further revisions to the draft. Some small wording edits and clarifications have been completed in the interim.

The final ON TO 2050 plan will be available via the web. This draft provides a single document for complete review, and includes all visuals that are conducive to this non web based format. Finalization of formatting and visualizations is still underway, while text and the recommendations of the plan will not change beyond addressing any proofreading errors. Staff are requesting a recommendation for adoption of the Plan.

In association with the Plan, the FFY 2019-2024 Transportation Improvement Program (TIP) and conformity determination are presented for approval. The air quality impacts of the Regionally Significant projects contained in ON TO 2050 and existing Not Exempt or Exempt Tested projects included in the FFY 2014-2019 TIP that are anticipated to be carried forward into the FFY 2019-2024 TIP were also analyzed. This analysis found that ON TO 2050 and the FFY 2019-2024 TIP meet all applicable requirements for conformity to the State Implementation Plan (SIP) and applicable provisions of the Clean Air Act. Public comment on these materials was conducted in tandem with ON TO 2050 outreach, including publication of materials, open houses, and the public hearing. Staff are also requesting a recommendation for adoption of the ON TO 2050/FFY 2019-2024 TIP Conformity Analysis and FFY 2019-2024 Transportation Improvement Program (TIP) to the CMAP Board and MPO Policy Committee.



Amendment 18-09

In accordance with the required plan update conformity analysis policy, CMAP staff asked programmers to submit changes, additions, or deletions to non-exempt projects included in the FFY 2014-19 TIP that are anticipated to be carried forward into the FFY 2019-24 TIP and to proposed ON TO 2050 Regionally Significant Projects (RSPs) for inclusion in the regional air quality analysis. Of the changes requested, twenty-one projects required air quality conformity analysis. Below is a summary by type of requested change.



If the 2019-24 TIP and ON TO 2050 are approved, eleven Regionally Significant Projects (RSPs) and three new non-exempt projects will be included in the conformed TIP for the first time. One

additional project that was previously delayed, and thus de-conformed, is also included. The federal government requires regional planning agencies to demonstrate fiscal constraint by determining that sufficient resources will be available to construct projects recommended in the plan. Careful selection of these projects must meet the federal standard of fiscal constraint, while also helping to achieve regional goals. These types of projects are included in the conformity analysis because funding for phases beyond preliminary engineering has been identified in the TIP or within the planning horizon of ON TO 2050. Non-exempt projects with only preliminary engineering funding and exempt tested projects are excluded from conformity analysis, except in those years when a plan is required by the MPO.

The new RSP interstate projects are:

- TIP ID 03-18-0017: I-290/IL 53 Interchange Improvement RSP 21
- TIP ID 09-12-0036: I-80 from Ridge Rd to US 30 Lincoln Hwy RSP 36
- TIP ID 12-02-9034: I-55 from I-80 to Coal City Rd RSP 34
- TIP ID 12-12-0037: I-80 Managed Lanes from U.S. 30 to I-294 RSP 37
- TIP ID 13-18-0005: I-290/I-88/I-294 Interchange Improvement RSP 24

The new Arterial RSPs are:

- TIP ID 07-14-0003: Vollmer Road from Kedzie Avenue to Western Avenue RSP 145
- TIP ID 08-95-0024: IL 83 Kingery Hwy from 31st St to N of 55th St, S of 63rd St to Central Avenue - RSP 111
- TIP ID 09-18-0015: Randall Road from North County Line Road to Orchard Road -RSP 46
- TIP ID 10-07-0001: IL 60/IL 83 from IL 176 to Townline Road (IL 60) RSP 10
- TIP ID 11-16-0008: IL 62 (Algonquin Rd), IL 25 (JF Kennedy Memorial Dr.) to IL 68 (Dundee Rd.) - RSP 11
- TIP ID 12-18-0021: Wilmington-Peotone Road: IL Route 53 to Drecksler Road RSP 56

The new non-exempt projects are:

- TIP ID 01-17-0025: Roadway Improvements to Support the Update to the South Lakefront Framework Plan
- TIP ID 12-11-0054: Kings Road from Hassert Blvd to Rodeo Drive
- TIP ID 12-18-0019: I-55 I-80 to US 52 (Jefferson St) and @ ILL 59

Sponsor indicated status change to a recently de-conformed project that is no longer delayed:

TIP ID 12-07-0021: Ridge Road from South of Minooka Rd to McEvilly Road

Other changes to existing projects are described below.

Limits are the cross-streets, mileposts or other boundaries which define the extent of a project. There are no projects with significant limit changes.

The completion year indicates when a project is anticipated to be in service to users. The conformity analysis is conducted for selected analysis years between now and 2050. The

analysis years are currently 2020, 2025, 2030, 2040 and 2050. If a change in completion year results in moving a project across an analysis year, the project must be revised in the conformity analysis.

The following non-exempt RSPs crossed an analysis year:

- TIP ID 01-06-0052: 63rd St at BRC 59th St Line (CREATE GS-01) RSP 109
- TIP ID 12-10-9001: I-55 Managed Lane from I-355 to I-90 I-94 (I-55 Stevenson Express Toll Lanes) - RSP 146

The scope of a project is determined by the **work types** associated with the project.

- Non-exempt work types are expected to affect air quality and must be included in the conformity analysis. Examples of non-exempt work types are adding lanes to a road, interchange expansion, signal timing and the major expansion of bus route service.
- Exempt tested work types do not require an air quality conformity analysis, but the region has chosen to include the impacts of these types of projects in the travel demand model. Exempt tested projects include new commuter parking lots, rolling stock replacement, and road reconstruction with lane widening to standard widths (e.g., 10 feet to 12 feet).
- Exempt work types do not require an air quality conformity analysis.
 Examples of exempt work types are intersection improvements and rail station modernization.

This proposed ON TO 2050 Regionally Significant Project revision is now defined by the addition of integrated flex lanes, implementation of SmartRoad technology, reconfiguration and improvements to the interstate interchanges for the conformity analysis.

• TIP ID 13-16-0009: I-294 Central Tri-State Reconstruction and Mobility Improvements from Balmoral Avenue to 95th Street –RSP 23

A status change to "Not Conformed", of these former GO TO 2040 Major Capital Projects. Unconstrained regionally significant projects cannot receive environmental clearance from FHWA or FTA under NEPA, or access certain federal funding and financing programs, without being in the fiscally constrained portion of the plan. A plan amendment, TIP amendment, and conformity analysis would be required before any phases beyond Phase 1 Engineering could be included in an active year of the TIP (FFY 2019-2024).

- TIP ID 12-02-9024: Illiana Expy from I-55 to I-65 (IN)
- TIP ID 10-06-0061: IL 53 North-South Tollway from IL 120 to Lake Cook Rd IL53/120 Tollway
- TIP ID 10-94-0047: IL 120 from Wilson Rd to US 41 IL 53/120 Tollway (IL 120 Bypass)

The public website of the **eTIP database** is available for current project information. Newly submitted change details are found in the **18-09 Conformity Amendments** report.

The regional travel demand model was run using the updated networks. The resultant vehicle miles traveled (VMT) by vehicle class, speed, time of day, and facility type were entered into the

US Environmental Protection Agency's MOVES 2014a model. The model generated on-road emission estimates for each precursor or direct pollutant in each analysis year.

For ozone precursors volatile organic compounds (VOC) and nitrogen oxides (NOx), the resulting emissions inventories estimates fell below the applicable budgets for the ozone maintenance State Implementation Plan (SIP).
