- 4.0 Delivery Congestion Reduction Pilot Program**
Representatives from City Tech -- a Chicago-based non-profit focused on collaborative solutions for complex urban challenges – and HERE Technologies will provide an update on their **Delivery Congestion Reduction pilot program**. The pilot analyzed traffic and carrier delivery data to identify alternative delivery models and their corresponding reduction in congestion and delivery costs. A final report is currently being drafted.
- 5.0 Update on CMAP Freight Projects**
Staff will provide an update on various freight-related projects ongoing at CMAP, including the IIPD Master Plan, truck routing studies, and **grade crossing feasibility studies**.
- 6.0 Logistics Facilities and Truck Traffic**
Dr. Kazuya Kawamura will provide an overview of research into decentralization of urban logistics facilities. Conducted using large freight survey data sets, the research shows that the relationship between the spatial distribution of urban logistics facilities and truck traffic is complex and nuanced, and logistics sprawl does not always lead to increases in truck traffic.
