

Help set priorities, coordinate decision-making, obtain grants/funding




# **Fox River Corridor Plan**

Comprehensive plan for the Fox River and its communities from Burtons Bridge to Johnsburg




# **Economic development**

### Issue:


 Reinvestment efforts may be interrupted by COVID-19

- Management of river and supporting infrastructure needs improvement




# Flooding and water resources management

 Citizen groups are working to improve water quality




# **Open space and habitat**


# **Access and Connectivity**
