**Methodology/Sources:**

Column A Allotments 1972-2016 are from IDOT.

Column B STP-L obligations as reported by IDOT/FHWA and tracked by CMAP (current as of 9/30/2016).

Column C The difference of Column A & B. The full unobligated balance is utilized to demonstrate fiscal constraint in the Transportation Improvement Program (TIP)

Column D Committed AC funds are funds in Advanced Construction in FHWA's FMIS database as of 9/30/16 that when converted to a federal obligation would likely use STP-Locally Programmed funds.

Column E Carryover Available for Programming is the Balance (Column C) - Committed AC funds (Column D)

Column F Current year (FFY 17) allotment (per IDOT) distributed using the 2010 census population.

Column G & H FFY 2017 Mark is the Adjusted Balance (Column E) + FFY 17 allotment (Column F). A council with \$0 Mark has a negative balance (displayed in column H).

Column I FFY 2018 Mark = FFY17 allotment (Column F) (McHenry's Mark is \$0 as their remaining balance is greater than their anticipated FFY 17 allotment).

Column J FFY 2019 Mark = FFY17 allotment (Column F) (McHenry's Mark was reduced by \$3,101,657 to account for obligations in prior years via Advanced Funding).

Column K FFY 2020 Mark = FFY17 allotment (Column F)

Column L FFY 2021 Mark = FFY17 allotment (Column F).
