**1. Where are the Proposal Submittal Forms located? Can they be included as part of the solicitation package? Specific request the following forms: certification for federally funded agreements, specific provisions for certifications regarding workers compensation, surge insurance, and the FTA certification regarding lobbying.**

**2. What is the best way to provide the requested Resume/CV? Can I provide a link to my LinkedIn profile?**
