### 1.0 Call to Order

The meeting was called to order at 9:00am.

### 2.0 Welcome and Introductions

All attendees introduced themselves.

## 3.0 Approval of the Minutes

Motion to approve the minutes was made by Tim Angell and seconded by Lori Clark.

### 4.0 Agenda Changes and Announcements

No agenda changes were made.

#### 5.0 Staff Report

Staff informed the committee that CMAP is working with partner organizations such as MPC, Mayors Caucus, the Federal Reserve Bank of Chicago to determine strategic ways in which funds for the Housing and Economic Recovery Act of 2008 which appropriates \$3.92 billion for grants to states and localities for the redevelopment of abandoned and foreclosed homes. Over the next few weeks, CMAP will analyze data and identify specific strategies to proceed with the program.

## 6.0 GO TO 2040 Update

## 6.1 Snapshot: Business Location Decisions

Annie Byrne and Matthew Maloney presented initial findings on factors that drive business location decisions. The analysis looked at existing conditions and recent trends regarding the geographic location patterns. Staff sought suggestions from the committee for further research.

Tim Angell stated that taxes and incentives can be a factor on location decisions. Members suggested that the report look at the importance of taxes and incentives in so far as they are part of a location decision. Tracey Bosman added that the report could benefit from showing how the region compares against other regions. Harry Pestine reminded staff of the Corridors of Opportunity project by DCEO and recommended staff follow-up with them on their findings. He also recommended they focus on disinvested areas and vacant land to include work done on previous reports at CMAP. Lori Clark suggested staff consider the importance of business expansions which also plays a big role location decisions. The committee asked for future update as the work progresses and thanked staff for the report.

### 6.2 Regional Indicators Project

Andrew Williams Clark reported that staff had developed recommendations for tracking taking into account input from the working committees, workshop participants and other stakeholders. Following Board approval in November, CMAP staff will prioritize data and begin to develop visualizations and indicators for distribution to stakeholders and the public.

### 7.0 Public Outreach

Ylda Pineyro introduced the *GO TO 2040 partnership* campaign. The program is an effort to join regional stakeholders, local governments and other groups in the region to work toward the common Regional Vision. The Partnership allows participants to have access to planning experts, various tools and resources about regional comprehensive planning, and the opportunity to make sure their organization's voice is heard.
