#### 1.0 Call to Order and Introductions

# 2.0 Agenda Changes and Announcements

Janice Morrissy made one change to previous minutes regarding committee attendance.

# **3.0 Illinois Association of Realtors Presentation:** Sharon Gorrell, National Association of Realtors

Committee members were shown *State of the Illinois Economy 2011 "Connecting the Dots"*, presented by Dr. Geoffrey J.D. Hewings, University of Illinois and Director of the Regional Economics Application Laboratory. *"Connecting the Dots"* is a housing forecast based on Multiple Listing Service sales reported by participating local Realtor Associations throughout Illinois. The research links jobs, unemployment and other economic indicators with real estate data for the state and the nine-county Chicagoland region (Cook, DeKalb, DuPage, Grundy, Kane, Kendall, Lake McHenry and Will). # 4.0 Local Technical Assistance Program-Bob Dean, CMAP

LTA staff discussed the community application process as well as the project priority ranking system. The committee was updated on the six projects that will be starting immediately. Nancy Nutter reported communities are excited to be part of the LTA program but suggested more clarification on what submitted projects were selected (for those accepted communities with multiple submissions) and additional details on the process. Pete Saunders noted LTA staff will be working with the selected communities to

prioritize and scope their projects

Sharon Gorrell asked about cargo related development relating to the Blue Island Comprehensive Plan. Pete informed the committee, for a comprehensive plan, COD, housing and all development data will be used to create a plan. Nicole Nutter suggested committee members look at Center for Neighborhood Technology's COD report. Janice Morrissy also recommended the Chicago Southland's Green TIME Zone study.

### 5.0 Homes for Changing Region Update-Drew Williams-Clark, CMAP

Drew Williams-Clark delivered a brief update on the Homes for Changing Region program, including plans for new analysis presentations on supply and demand in April 2011. Mr. Williams-Clark also informed the committee the West Cook Housing Collaborative and Northwest Suburban Housing Collaborative, through the LTA program, will be part of the *Homes* expansion project. Alan Quick inquired about the funding source for the additional *Homes* participants, Mr. Williams-Clark responded that HUD Sustainable Communities grant dollars will be utilized.
