Dear Mayor Schielke:

The DuPage Mayors and Managers Conference (DMMC) requests advanced funding in the amount of \$4,070,000 (federal STP) for the construction phase of the projects described below. Given the possibility for reprogramming of excess American Recovery and Reinvestment Act (ARRA) funding and additional funding from the potential "Jobs for Main Street Act" (H.R. 2847), DMMC may reduce the STP funds used on these projects. DMMC staff will work with CMAP staff to ensure proper accounting of the funds used and will notify the Council of Mayors Executive Committee of any advanced funding that is not used.
