### **1.0 Call to Order**

Claire Bozic, Chair called the meeting to order just after 1:00 p.m.

### **2.0 Agenda Changes and Announcements**

There were no agenda changes or announcements.

### **3.0 Approval of Minutes**

A motion by Chuck Sikaras was seconded by David Zattero to approve the minutes of the February 18, 2011 meeting as presented. All in favor, the motion carried.

### **4.0 Project Screening Criteria and Data**

CMAP staff presented the proposed project screening criteria and data used in the analysis. Todd Schmidt presented maps of the following proposed project screening criteria:

- Projects located on the Congestion Management System. This includes the Interstate System, National Highway System (including intermodal connectors), Strategic Regional Arterial System (SRA), and other principal arterials.

- Projects located along planned RTA TSP routes and arterial bus routes.
- Vehicle per lane data calculated from Illinois Roadway Information System (IRIS).
- Travel time index calculated from HiStar data acquired from IDOT.

Tom Murtha presented maps of the following proposed project screening criteria:

- Freeway congestion and crash data from CMAP analysis.
- Projects located in high crash locations.

David Zattero asked if CMAP considered including the Strategic Regional Transit System (SRT) in the project screening criteria. Tom Murtha responded that the system is not up-to-date and that the RTA TSP routes and existing arterial bus route system would suffice for this process. David Tomzik inquired where CMAP staff obtained the mapped RTA TSP routes because many Pace routes were not included. CMAP staff responded that the file was obtained from RTAMS and will add Pace's TSP routes once they were identified by Pace. Mr. Tomzik said he thought the RTAMS mapped routes may not be up to date and offered to provide current information. Steve Travia suggested adding IDOT's 5% crash intersection to the screening criteria.

## **5.0 Developing Project Status**

Participating agencies were invited to discuss projects that are being planned to be submitted for CMAQ funding. Sven Zimdahl, with CivilTech Engineering Inc, gave a presentation on Cook County Highway Department's project on Lake Cook Rd. David Tomzik informed the group that RTA, in coordination with the CTA and Pace, is planning to submit a TSP system plan for CMAQ funding. The TSP application will develop a five year plan for implementing TSP in certain corridors. David Zattero discussed projects that Chicago DOT is planning to submit for CMAQ funding. Projects included signal interconnects, arterial detection, adaptive signal control, and en-route travel information systems. David Ziesemer discussed projects DuPage County is planning to submit for CMAQ funding. Projects include a bottleneck elimination project and signal interconnects. Jonathan Nelson informed the group that Lake County will be applying for bottleneck elimination, converting four-way stops to roundabouts, and signal interconnects. Tom Szabo told the group that Kane County will be applying for roundabouts, intersections improvements, and the Stearns Rd. smart corridor project. Kristina Kupkowski shared that Will County will mostly apply for intersection improvement projects. Steve Travia informed the group that IDOT will be submitting applications mainly for roundabouts and intersection improvements.

## **6.0 Signal Optimization Eligibility**

CMAQ eligibility of signal optimization was discussed. Signal timing is not eligible for CMAQ funding because it is an operations related cost. Capital costs, such as putting in a new signal system are eligible for CMAQ funding. However, if optimizing the signals is a critical component of an eligible project, such as transit signal pre-emption, it has been funded as a one-time effort as part of project implementation. We expect that this will continue to be the case for TSP and for adaptive signal control system implementation.

**7.0 Other Business**

There was no other business before the Regional Transportation Operations Coalition.
