The plan was last adopted by NIPC, a CMAP predecessor agency, in 1997. Revisions to the Trails Element consist of alignment and status changes, as well as additions and deletions of proposed trails [the proposed regional trails element will be posted to the CMAP Web site when available, and a separate email will be distributed]. Meeting participants will be asked to provide feedback regarding the revised trails element in a workshop format, marking up draft maps. Staff will also seek input regarding priority ranking of the plan corridors. Lastly, staff will update committee members about the process for adopting the update.
