30 day public comment: 11/8/2024 - 12/10/2024, TC considers 12/20/2024, MPO Policy considers 1/9/2025.

TIP users must review all TIP projects approaching federal fiscal year 2025 to carry forward those projects that will remain active in the eTIP database. Denials must be addressed by 9/24/2024.

Using the Schedule:

1. Find your target letting date in the far right column.
2. Determine which deadline column(s) apply to your project:
 - a. For CMAQ/CRP/TAP funded projects, if a schedule, scope, or cost change is needed, or a project phase needs to be reinstated from the deferred list, refer to the "CMAQ/CRP/TAP Change"
 - b. For all other federally funded projects, refer to the "TIP Revisions Due" column for the date by which TIP changes must be submitted to CMAP.

When are TIP Changes necessary:

1. If the cost of the project phase seeking federal authorization differs from the amount programmed in the CMAP TIP.
2. If the project phase is seeking authorization in the current FFY, but is programmed in the CMAP TIP in a different FFY.
3. If the project title, location, or scope has changed since initially entered in the TIP. (FHWA will not authorize funds if the agreement description differs from the TIP.)
4. If the project schedule has changed.
