Mayor Schielke,

The North Central Council of Mayors requests that the Council of Mayors Executive Committee approve our request for advance funding in the amount of \$1,648,929 in federal Surface Transportation Program (STP) dollars for the following projects

- Hillside – Butterfield Road EII – This is part of a reconstruction project which has CMAQ funds assigned to ROW and C. EI approval is imminent.
- Melrose Park – Division Street Resurfacing – Standard resurfacing project.
- Northlake/Elmhurst – I-294/I-290/IL 64 Ramp – This project has been a long term commitment of the Council. The Council has dedicated funds for an Access Justification Report, EI, and is now in EII. Due to further requirements requested by the Illinois Tollway, the cost of EII has risen. (See attached documentation). This project is also a part of the Elgin O’Hare Western Access. DuPage County is currently compiling grant applications for TIGER and CMAQ to aid in funding construction. The currently allocated funds for EII are insufficient and the project team expects to run out of money some time in May or June 2015. The Council already has about 1.7m tied into EII.

The McHenry County Council of Mayors respectfully requests that the Council of Mayors Executive Committee approve our request for advance funding in the total amount of \$719,250 in federal Surface Transportation Program (STP) dollars at your January 27, 2015, meeting.

The request is for the following two projects:

1. Algonquin Road/Plum Tree Road/Doyle Road project in the Village of Fox River Grove, which Algonquin Township Road District is participating in. The project is scheduled for the April 24, 2015, letting and requests \$622,880 in federal STP dollars.
2. McCullom Lake Road project in the City of McHenry was previously approved for \$964,530 advance funding at the September 9, 2014, meeting. Due to the inclusion of the Railroad Force Account work and increase construction cost, a \$96,370 increase in federal STP dollars is being requested. The project is scheduled for the April 24, 2015, letting.

CMAP has indicated there is programmable STP dollars that the region needs to spend down. We look forward to moving these projects along to the April letting.
