1.0 Call to Order

Committee Co-Chair Nancy Firfer called the meeting to order at approximately 9:10 a.m.

3.0 Approval of the Minutes-Thursday, September 17, 2015

Following a motion and a second, the members present unanimously approved the minutes.

4.0 Homes for a Changing Region Update

Committee members received updates on the current *Homes for a Changing Region* projects: DuPage 2 (Hanover Park, Glendale Heights, and West Chicago) and the Round Lakes cluster. The committee also discussed the potential future work under this program, including the development of a subregional housing policy guide and ongoing contracted work with DePaul University.

5.0 Next regional plan: Engagement and voting opportunities

CMAP staff member Elizabeth Schuh presented on opportunities during the development of the next plan for interim products and answered questions about the material.

6.0 Next regional plan: Place-based approach alternatives

CMAP staff member Kristin Ihnchak presented on the place-based approaches used by many peer MPOs and their potential utility for the next plan. Committee members discussed the recommended “layers” approach. Members offered many comments, including about how to balance the differing resolutions for many possible layers and the importance of thinking about the frequency of layer updates from the outset. A long discussion occurred on whether and how to aggregate layers in order to assist potential implementers so as to allow for an external understanding about how various layers interact with one another.

7.0 Next regional comprehensive plan: Housing supply and affordability strategy paper

CMAP staff member Jonathan Burch presented on the housing supply and affordability strategy paper, introducing the paper, timeline, and scope and providing context to potential work by highlighting what came out of the GO TO 2040 recommendations and how that may compare with the approaches of other regional planning organizations. The committee engaged in long discussions on the role of CMAP in the housing sphere and how to define a well-balanced housing supply. Committee members discussed the importance of considering factors such as income and race when considering housing supply.
