## Five Alternative Futures could shape the Chicago region by 2050

*Now through August, residents can give feedback for the ON TO 2050 regional plan via web surveys, kiosks, workshops, forums, and social media*

CHICAGO, April 5, 2017 -- Starting now, every northeastern Illinois resident can comment on five distinct outcomes for the region to inform the ON TO 2050 comprehensive plan in development by the Chicago Metropolitan Agency for Planning (CMAP). An extensive "Alternative Futures" public engagement phase runs from April through August.

The five futures -- Changed Climate, Walkable Communities, Innovative Transportation, Transformed Economy, and Constrained Resources -- describe a variety of intertwined factors that could significantly shape our region for decades to come. Based on more than a year of analysis by CMAP and its partners, the Alternative Futures ask residents to consider:

- What if impacts of climate change have intensified by 2050?
- What if more people choose walkable, mixed-used communities by 2050?
- What if new technologies enhance transportation by 2050?
- What if the economy has been transformed by 2050?
- What if public resources are further constrained by 2050?

CMAP will feature one of the futures each month from April through August. ON TO 2050, slated for adoption in October 2018, will reflect input collected via various methods -- including online surveys, public workshops, topical forums, and kiosks at locations across the seven-county region. "These five futures are based on variables that tend to overlap," said Joe Szabo, CMAP executive director, "so we won't be asking people to choose one over the others. The futures are also not predictions of what will happen. Instead, by discussing what *could* happen, as a region we can plan more effectively to meet potential challenges and opportunities."

Starting in April with [Changed Climate](#), CMAP will post a new web survey for one future per month. Residents can explore ON TO 2050 [kiosks](#) located in Cook, DuPage, Lake, Kane, Kendall, McHenry and Will counties. Other feedback methods include [Twitter](#) and [Facebook](#) via the hashtag #2050BigIdeas.

People may also provide feedback in person at dozens of [Alternative Futures workshops](#) CMAP will convene throughout the region to discuss the Alternative Futures. To arrange one for your community or group, email [onto2050@cmap.illinois.gov](mailto:onto2050@cmap.illinois.gov).

In addition, CMAP and partners will spark debate by co-hosting five [Alternative Futures forums](#), which conclude an ON TO 2050 series held around the region during the past year:

**Innovative Transportation.** "Harnessing Technology for Future Mobility," Thursday, June 22, 9:00 to 10:30 a.m., Illinois Institute of Technology (co-sponsor), 3201 S. State St., McCormick Tribune Campus Center, Chicago.

**Transformed Economy.** "The Future of Economic Opportunity," July 2017, Homewood. Details to follow.

**Constrained Resources.** "Doing More with Less in 2050," August 2017, Libertyville. Details to follow.

"By planning inclusively, we can grow inclusively," said Szabo. "We look forward to hearing about residents' ideas, hopes, and concerns. This public feedback is essential so ON TO 2050 can help improve metropolitan Chicago's quality of life and economic prosperity for today's 8.5 million residents and for generations to come."
