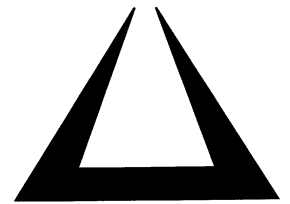

The McHenry County Council of Mayors respectfully requests that the Council of Mayors Executive Committee approve our request for advance funding in the total amount of **\$2,054,400** in federal Surface Transportation Program (STP) dollars for FFY 2017 at your October 25, 2016, meeting.

The request is for the following projects:

1. Church Street project in the Village of Johnsburg (TIP #11-15-0007; MFT Section #15-00013-00-PV; C-91-469-16; 4003812). The roadway widening, resurfacing, sidewalk and intersection improvement project is scheduled for the March 3, 2017, letting. Requesting a total of **\$1,500,000** in federal STP dollars for construction/CE phase, being \$1,291,600 for construction and \$208,400 for construction engineering.
2. Lake Avenue project in the Village of Lakewood (TIP #11-15-0003; MFT Section #14-00013-00-RS; C-91-468-16; 4003813). The roadway resurfacing with bike lane project is scheduled for the January 20, 2017, letting. Requesting a total of **\$554,400** in federal STP dollars for construction/CE phase, being \$504,000 for construction and \$50,400 for construction engineering.

CMAP has indicated there is programmable STP dollars that the region needs to spend down. We look forward to moving these projects along to the January letting.
