Strategy Paper Scope

Focuses on long-term changes needed to build regional health equity and incorporate health across ON TO 2050 topics.

- Phase 1: **Understand the public health landscape and identify MPO role** (January – April, 2017).
- Phase 2: **Assess future needs** (March – July, 2017 .
- Phase 3: **Strategy paper development and review** (July – December, 2017 .
- Phase 4: **Build capacity in health equity** (January 2018 and beyond).

Strategy Paper Objectives

- Provide background research and analysis on public health.
- Outline policy direction that can inform the goals or recommendations of the regional plan.
- Define future research needs or follow-up activities for CMAP and agency partners.
- Deliverables:
 - Mission statement
 - Literature review
 - Summary of preliminary findings
 - Final 20-30 page strategy paper
