RTA is the oversight, funding and regional planning agency for the transit Service Boards including Chicago Transit Authority (CTA) bus and rail, Metra commuter rail and Pace suburban bus and paratransit. Through its Community Planning program, the RTA provides funding and planning assistance to local governments for planning projects that are mutually beneficial to local communities and the RTA transit system. Projects primarily focus on transit oriented development (TOD), plan implementation, and transit improvement plans, which can provide economic development benefits to the communities and help maximize the use of the regional transit system.

Bicycle-Pedestrian Planning

Classroom 320, 3rd Floor

Communities around our region are developing plans and project delivery strategies for bicycle and pedestrian facilities. This session will give you a chance to hear from three communities in various stages of progress on bicycle and pedestrian planning work: Richton Park, Willow Springs, and Evanston. Richton Park's presentation will focus on using its LTA-funded Comprehensive Plan as a starting point to develop a bicycle and pedestrian network, which then led it to undertake the development of a Complete Streets policy and a community-wide Active Transportation Plan. The Village of Willow Springs will present on its small-scale planning projects that have fast-tracked project implementation on local roads. Evanston will discuss lessons learned from its 2014 Bike Plan update and on bike plan implementation, including best practices in public engagement and the role that local advocates can play in advancing your community's goals.

Initiating Intergovernmental Cooperation & Shared Services

Classroom 326, 3rd Floor

Benefits and lessons learned of evaluating and initiating municipal partnerships for shared services and joint procurement in northeastern Illinois will be discussed by panelists representing a range of experiences in municipal collaboration. Participation in the established Municipal Partnering Initiative (MPI) as well as more recently formed partnerships will be described.

This session will discuss best practices in partnership evaluation and initial steps municipalities can take to develop strategies that reduce cost while maintaining delivery of high-quality services. The planning process for the Lower Fox River Partnering Initiative Shared Services Study will be discussed to highlight resources available through CMAP's LTA program to assist municipalities in exploring innovative ways to coordinate service delivery.

Planning for Flooding and Climate Challenges

Classroom 330, 3rd Floor

CMAP and its partners are taking action to help communities address two related topics: planning to address current flooding challenges, and planning for a changing climate, which may include increased risk of flooding due to changing precipitation patterns. CMAP will present a new approach to assessing flooding risk in the region's communities using GIS tools, and the results of applying these tools in South Holland. DuPage County Stormwater Management will present some of their recent work to reduce flooding and damages in DuPage County communities, and how they intend to use climate data to plan for future stormwater challenges. Illinois-Indiana Sea Grant and the Midwest Regional Climate Center will present on a collaborative project to incorporate climate data and vulnerability assessments in local plans.

The Devil is in the Details: Subarea, Corridor, and District Planning Classroom 420, 4th Floor

Many communities have specific areas that could benefit from more detailed recommendations or unique issues that typically aren't addressed in a Comprehensive Plan or other community-wide initiatives. This session will focus on case studies from the Village of Franklin Park, Will County Land Use Department, and City of Chicago and will highlight the types of detailed sub-area and neighborhood planning that can be facilitated through the CMAP and RTA technical assistance programs. Speakers will highlight how these projects have enabled communities to improve regional infrastructure to the benefit of both regional and local economic development, address urban issues in unincorporated areas and maximize benefits from infrastructure improvements, and identify strategies to combat community-wide issues of instability while encouraging reinvestment in targeted areas.

Rivers as Assets: Planning for Riverfront Communities

The rivers of northeastern Illinois have long been major influences on its natural resources, development patterns, and industrial economy. Throughout the region, communities are increasingly planning for their riverfronts, recognizing the unique assets and opportunities that rivers represent. This panel discussion will feature three local examples of riverfront planning along the Fox River, Chicago River, and Calumet River. Representatives from the Village of Algonquin, Chicago's Chinatown, and Southeast side of Chicago will discuss recent plans they have completed that demonstrate the importance of local planning in achieving river-related goals and receiving assistance and funding for implementation.

Transit-Oriented Development Planning and Implementation Classroom 426, 4th Floor

This session focuses on Transit-Oriented Development (TOD) planning and implementation assistance provided through the RTA's Community Planning program starting with an example from the recently completed TOD Plan with the City of Highwood who is now making implementation progress since plan adoption. The Village of Lemont completed a station area plan in 2005 and has since revised their zoning ordinance, participated in a developer panel and has experienced some redevelopment. Finally, the Village of Mundelein completed a TOD Plan in 2004 and has since revised its zoning code and sign code, as well as removed other barriers, which have paved the way for market-rate housing, income-assisted housing, business incubator space and the demolition of blighted/obsolete structures. Pace recently completed a study of how to improve a seven-mile stretch of the North Avenue Corridor, a well-established automobile-oriented corridor in the region, with ways to improve the corridor to make it more attractive to people using transit, walking and biking.

Working with Developers

Different opportunities and challenges come with redeveloping key sites and attracting developers. In 2012, CMAP and Urban Land Institute Chicago (ULI) assisted the City of Joliet with the redevelopment of the former Joliet Correctional Center and U.S. Steel Site. In 2015, RTA assisted the Village of Forest Park with amending its zoning codes to allow for a mix of uses in development and redevelopment projects along key transit corridors. The panelists will share their experiences collaborating on local technical assistance projects with CMAP and RTA, and ULI Chicago will discuss their experiences working on these and similar projects.

Government Agencies

City of Chicago and Chicago Transit Authority (CTA)

Nongovernmental organizations that submit applications are required to secure the support of the local governments that their projects would affect. Staff from the Department of Planning and Development and the Department of Transportation will be on hand to discuss project ideas with NGOs within the City. The CTA, which serves the City of Chicago and 35 surrounding suburbs, works closely with CMAP and the RTA on land use and transit planning projects that improve performance and accessibility. www.cityofchicago.org and www.transitchicago.com

Illinois Department of Natural Resources (IDNR)

IDNR is an important partner for LTA applicants planning for improved access to state parks and recreation areas throughout Illinois. Applicants interested in recreational trail planning could collaborate with IDNR to ensure that local trail planning enhances the state's current resources. Illinois Department of Transportation (IDOT)

Nearly all municipalities have a state highway within their borders, and any changes to the roadway or the land uses that surround it will need to be coordinated with IDOT. Communities that are interested in conducting corridor plans along a state highway will have a particular need to involve IDOT in their project. www.idot.illinois.gov

Illinois Environmental Protection Agency (IEPA)

IEPA works to safeguard the state's natural resources from pollution to provide a healthy environment for its citizens. By partnering with businesses, local governments, citizens, and CMAP through the LTA program on projects that address natural resources, IEPA is dedicated to continued protection of the air we breathe and our water and land resources.

Metra

Metra is the provider of commuter rail service in northeastern Illinois with 11 rail lines serving 241 stations across the six county region. Metra staff works with communities throughout the region to support land use planning efforts. Land use decisions are the jurisdictions of the communities, but Metra encourages land use planning that will be both transit supportive and transit oriented.

Metropolitan Water Reclamation District (MWRD)

MWRD protects the health and safety of the public in its service area, protects the quality of Lake Michigan, improves the quality of water in watercourses in its service area, protects businesses and homes from flood damages, and manages water as a vital resource for its service area. The District works with CMAP on many water-related projects to provide guidance on funding sources for improvements, coordination on ongoing MWRD projects, and general guidance and assistance with stormwater management and best practices. www.mwrd.org

Pace

Pace is the suburban bus division of the RTA. Communities that want to improve bus corridors, explore land use planning that complements transit, and improve overall access to transit can work with Pace to identify opportunities that enhance service and improve the transit experience.
