The agency and its partners are now implementing ON TO 2050, a new long-range comprehensive regional plan to help the seven counties and 284 communities of northeastern Illinois implement strategies that address transportation, housing, economic development, open space, the environment, and other quality-of-life issues. Position Purpose

The intern will be responsible for providing assistance in collecting and analyzing project data to support CMAP's transportation program management activities.

Essential Functions

- Assist with documentation of core decisions in development of the transportation planning process.
- Analyze transportation project expenditures to assess trends in project delays and cost changes.
- Assist with development of materials for certification review.
- Other responsibilities as directed by supervisor.

Knowledge, Skills, and Abilities

- Applicants should have a working knowledge of common operating systems and software applications including Windows 7 and Microsoft Office with a focus on Microsoft Excel.
- Proficiency in reading, writing, and communication among team members is required. Basic database knowledge (particularly Microsoft Access and SQL) is desired, but not required.

Education and/ or Experience

- Applicants must be entering their junior or senior year in spring, 2019. Graduate applicants are expected to complete their programs in 2020 or 2021.

- Current enrollment in a Bachelor or Masters' degree program in Public Administration, Urban Planning, or Civil Engineering is recommended.
- It is important that applicants have a general understanding of personal computers, database systems, and Microsoft Office software.

While the intern will be supervised by CMAP staff, they will be expected to take a high level of responsibility for their own work, and should be self-motivated.

Internship Timeframe

Depending on the student's availability, this is a full-time summer position beginning in May or June 2019. It could potentially continue into the 2019-2020 school year, but that is not guaranteed. Minor start and end-date accommodations may be made upon request.
